

## 2025-2026 DRIVER EDUCATION

Students must be at least 14 years of age and have their Iowa Instruction Permit to register. It is recommended that students have basic driving skills prior to the start date.

Students may attend either location, choosing the dates that work best for their schedules.

**ON-LINE instruction requires completion through independent study within the three-week timeframe. In addition, students will be scheduled two driving lessons each week.**
